

- State pension special budget


Deviations presented: **2003 – 2014**

# METHODOLOGY AND SCOPE



## Main sources of information

1. Planned budgets for 2003 – 2014 (Saeima regulatory enactment data base [www.saeima.lv](http://www.saeima.lv)).
2. Actual budget results data for 2003 – 2014 (Treasury data base [www.kase.gov.lv](http://www.kase.gov.lv))
3. Policy changes for 2008 – 2014 (regulatory enactment amendments) ([www.likumi.lv](http://www.likumi.lv) and Saeima regulatory enactment data base)

### Survey covers

92% of State special budget  
29% of State consolidated budget










Disability, maternity and illness social benefits 2003-2014, EUR




Disability, maternity and illness social benefits: difference compared to budget: "-" - excess expenditure, "+" - budget surplus (% from planned budget)




# WORK ACCIDENT SOCIAL BENEFIT SPECIAL BUDGET, 2003-2014 EUR


Work accident social benefits 2003-2014, EUR




Work accident social benefits: difference compared to budget: "-" - excess expenditure, "+" - budget surplus (% from planned budget)




# STATE PENSION SPECIAL BUDGET, 2003-2014 EUR

## POLICY CHANGES: DEFINITION

---

- **Amendments in social laws** that were not taken into consideration during the budgeting process and that have impacted actual results of the year
- Amendments in social laws that were implemented during the year and that affected expenditure of 1) employment, 2) disability, maternity and illness, 3) work accident and 4) state pension special budgets during the current year
  - 17 regulatory enactments
  - 159 amendments to regulatory enactments
