# 3. Participation of the Council in the evaluation of EU Recovery and Sustainability Mechanism projects

I.Steinbuka informs the Council about current developments in the EU Recovery and Sustainability Mechanism projects, notes the EC's recommendation to include independent fiscal authorities in the project evaluation process, as the projects have a direct impact on future economic growth and revenues. Notes that the role of the FDP may be very limited, but that it is necessary to respond to the process of evaluating these measures.

## 4. Fiscal Discipline Council OECD and EC project

**Reports:** N.Malnacs

N.Malnacs reports the current events of the OECD / EC project and its further progress. Emphasizes the support of OECD experts in strengthening the capacity gap between GDP and output gaps and medium-term revenue / expenditure forecasting in the Secretariat, and presents the next stages of the project.

Discussion between present members:

I. Steinbuka positively evalueates the support of OECD experts in developing the models, but points at the risks of making recommendations to the government in the current context of high uncertainty. A. Ubelis supports the strengthening of modeling and research capacity, but points out that the other components of the audit are currently facing economic and political disadvantages.

I.Steinbuka positively evaluates the practice of publishing monitoring reports during the lifting of fiscal restrictions, recommends continuing work on monitoring reports until the European Commission and the Latvian government make a decision on changes in fiscal policy. It was recommended that the timing of the release of the documentary be assessed in terms of reducing public tensions, as well as adapting the script to the priorities of the COVID-19 crisis as far as possible.
