1 Macroeconomic forecasts presentation

Ministry of Finance (MoF) informs on the latest macroeconomic indicators forecasts prepared for Latvia's Stability programme 2021-2024.

3 On the Recovery and Sustainability Mechanism Plan (RFF Plan)

Rapporteur: I.Šteinbuka, N.Malnačs

The members of the Council are introduced to 08.02.2021. MoF letter No. 5.1-25 / 21/720 on cooperation within the framework of the Recovery and Sustainability Mechanism. It invites the Fiscal Discipline Council to provide an opinion on possible cooperation and to provide an opinion on the draft RFF plan by 15 March. Earlier FDC has agreed with Productivity council (PC) and the researchers of Latvian University Productivity institute to form a joint platform to formulate opinion on RFF plan.

N.Malnacs proposes to extend the submission deadline of the report on RFF plan till at least April 1, 2021.

In order to able to start the project immediately, it was proposed to allocate 5000 euros to Latvian University productivity institute from the FDC budget. After identifying the experts to be involved in the project, if necessary, FDC will request additional funds from the Ministry of Finance. Considering, that the project will increase workload of the secretariat with tasks not envisioned in working plan, the Council advises to request some financing for the staff of the secretariat.

Discussion on cooperation and formulation of opinion of the Council on RFF plan.

Council opinion:

3.1. To accept the MoF's invitation to co-operate and to express the Council's opinion on the draft RFF plan. To support project financing project and individually to clarify Council members readiness to get involved into the formulation of opinion in an expert capacity.
